It is Dox's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://www.doxapp.co.za/> (hereinafter, "us", "we", or "<https://www.doxapp.co.za/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

- Website Visitors

Like most website operators, Dox collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Dox's purpose in collecting non-personally identifying information is to better understand how Dox's visitors use its website. From time to time, Dox may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website. Dox also collects potentially personally-identifying information like Internet

Protocol (IP) addresses. Dox only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

- Gathering of Personally-Identifying Information

Certain visitors to Dox's websites choose to interact with Dox in ways that require Dox to gather personally-identifying information. The amount and type of information that Dox gathers depends on the nature of the interaction. For example, we ask visitors who sign up at <https://app.doxapp.co.za/> to provide a name and email address or mobile number

- Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

- Links To External Sites

Our Service may contain links to external sites that are not operated by us. If you click on a third party link, you will be directed to that third party's site. We strongly advise you to review the Privacy Policy and terms and conditions of every site you visit.

- Aggregated Statistics

Dox may collect statistics about the behaviour of visitors to its website. Dox may display this information publicly or provide it to others. However, Dox does not disclose your personally-identifying information.

- Cookies

To enrich and perfect your online experience, Dox uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Dox uses cookies to help Dox identify and track visitors, their usage of <https://www.doxapp.co.za/>, and their website access preferences. Dox visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Dox's websites, with the drawback that certain features of Dox's websites may not function properly without the aid of cookies.
